Amendments which are recommended by the committee require a majority vote of the House of Delegates to adopt. Amendments which are not recommended by the committee require a 2/3 vote of the House of Delegates to adopt.

301.2.1 Open Water Guide to Operations—The Open Water Committee shall develop and maintain the *Open Water Guide to Operations* a guide for conducting open water events for the use of USMS open water officials and event hosts. The guide shall contain the governing policies, management of rules, and links to education applying to open water swims.

301.2.2 Postal Guide to Operations—The Long Distance Committee shall develop and maintain a USMS Postal Guide to Operations guide for conducting postal events. The guide shall contain the manner of implementation, governing policies, and management of the rules applying to postal swims.

Rationale: Maintain the requirement for a guide without explicitly calling out the name to provide flexibility. Also add missing word in 301.2.1.

The event host<u>should shall</u> eliminate known hazards on the course wherever<u>possible_feasible</u>. Known hazards that cannot be eliminated shall be marked and reported to all participants.

Rationale: Provides stronger language that parallels the style of the rest of Part 3 without placing undue burden on event hosts.

Note: Amended from August pre-convention version to provide greater flexibility by replacing "possible" with "feasible."

The course shall be certified by a licensed surveyor <u>before initial use and</u> every year if the turning points are not permanent and every five years if they are. For permanent courses, certification data need only be filed once unless structural changes have occurred since the original certification.

Rationale: USMS does not require continuing measurement for permanent non-bulkhead pools (refer to article 105.1.6C). Hiring surveyors to remeasure existing permanent courses on a periodic basis is expensive and thus another barrier to building permanent cable courses. Using language found in article 105.1.6C, this proposal seeks to remedy this requirement.

- **302.4.2 Time/Distance Basis**—A specified number of swimmers on each relay shall be considered in the computations for club scoring. The relay whose specified number of swimmers has the lowest cumulative time or the greatest cumulative distance shall be declared the winner. A similar method shall be used to determine second, third, and subsequent places. <u>Ties shall be allowed.</u>
- **302.4.3 Point Basis**—Points are awarded on the basis of overall finishing position, with one point for first place, two points for second place, etc. The points of specified relay members are added, and the lowest cumulative score determines the winning relay; the second lowest score, the second place, etc. <u>Ties shall be allowed.</u>
- **307.11.1** The highest placing USMS member in each age group of each individual open water and long distance pool national championship event shall qualify as a USMS Long Distance All-American for the calendar year in which the event was conducted. <u>Ties shall be allowed.</u>

Rationale: Although we have always assumed that ties would be honored, it has not been stated here before. This proposal corrects that omission.

Swimwear shall include only a swimsuit, cap or caps (including those made of neoprene when the water temperature is not greater than 78 degrees Fahrenheit), and goggles. Swim caps shall be defined as head gear conforming to a traditional swim cap design, <u>may have a chin strap</u>, and shall not extend to protect the neck and/or shoulders. Nose clips, ear plugs, and wristwatches are also allowed.

Rationale: There has been some confusion about whether chin straps protect necks and shoulders, or simply hold caps on heads. This proposal clarifies the intent of the rule.

Final Time—For cable swims, w When a final time has been submitted to the nearest second, 0.99 second shall be added to the time submitted. When a final time has been submitted to the nearest tenth of a second, 0.09 shall be added to the time submitted. For other open water swims, this timing adjustment is not required.

Rationale: USMS cable swim records are kept to the one-hundredth of a second (see article 308.1.2) so cable swim event directors are strongly encouraged to time all swimmers to the one-hundredth of a second to avoid having a potential record being erased in the rounding up. USMS records are not kept in other open water events, so reporting results to the one-hundredth of a second—required in the current rule—is unnecessary.

Athlete <u>Swimmer</u>—The <u>athlete</u> <u>swimmer</u> (or the <u>athlete</u> <u>swimmer</u>'s coach) is responsible for notifying the event host <u>director</u>, prior to the competition, of any disability of the <u>athlete</u> <u>swimmer</u> and of the requested modification. The swimmer/coach shall provide any assistant(s) or equipment if required.

Rationale: The event director—not the host—would be tasked with making a swimmer-withdisability situation work. Use "swimmer" to match the rest of Part 3.

- **B**-<u>C</u> Swimmer's name (as it appears on the USMS membership card).
- **€ D** Age.
- **D E** Club (official USMS club abbreviation).
- **E I** USMS number.
- **F G** Official time/distance or disqualified.
- **G** Special information (USMS records, overall place, place among gender, etc.). **<u>H</u>** Whether the time or distance is a USMS record.
- **307.8.2** Relay results shall be tabulated electronically by gender and age group in order of finish. Women's results shall be shown first, followed by men's results, then mixed-gender relays last. For each relay, the following information must be reported in the order designated on the results forms in the championship packet for that event: As a minimum, the following information shall be reported for each relay team:

<u>A Age Group.</u>

- **A B** Age group place.
- **B** <u>C</u> Team's full name (USMS club followed by blank, A, B, etc.).
- **C D** Official time/distance or disqualified.
- **D E** Names, ages, and official time/distance for each member of the team.

E Special information (national records, overall place, place among gender, etc.). $\underline{\mathbf{F}}$ Whether the total time or distance for the relay team is a USMS record.

Rationale: We need to include the Age Group in the results. The USMS number will give us unique identification. We need to require whether or not it's a USMS record, but other information is optional. The order in which the information is reported should be up to the LDC and National Office and not part of a rule.

308.1.1 <u>308.1.2</u> Individual and relay USMS records will be maintained in quarter-mile straightaway swims (1-mile and 2-mile) and time/distance pool events (1-hour, 3000-yard, 6000-yard, and 5-kilometer and 10-kilometer postal).

308.1.2 <u>308.1.3</u> To be considered for a USMS record, individual participants and relays must enter and complete the swim in a sanctioned event conducted in compliance with USMS rules.

Rationale: This has always been presumed but not previously stated. This proposal does that in language that parallels article 105.3.1. Renumber: 308.1.1 to 308.1.5 become 308.1.2 to 308.1.6.

A Record times shall be listed in hundredths of a second (two decimal places). If times are tied to the hundredth of a second, the results shall be declared a tie and records should be shared by all swimmers thus tied.

308.1.3 B When a record attempt has been timed to the nearest second, 0.99 second shall be added to the time submitted. When a record attempt has been timed to the nearest tenth of a second, 0.09 second shall be added to the time submitted.

Rationale: This clarifies the desired two-decimal precision of the timing requirement, using language that largely parallels article 105.3.8, while recognizing that results from postal swims are often timed and/or submitted to the second without decimals.

308.1.5 Cable Swims

A Cable swim records may be made only in stationary, fresh water. No cable swim records will be recognized in any kind of sea or ocean water.

B The official time for establishing records shall be achieved and determined in accordance with articles 303.7.1A and 303.7.4.

<u>C</u> Swimmers must wear category I swimwear as defined in article 303.4.2 to be eligible for USMS records.

308.1.4 D USMS records for cable swims may not be established by using a swimmer's split time in an individual event.

308.1.6 Postal Swims

- A Postal swim records can be made only in fresh water. No postal swim records will be recognized in any kind of sea or ocean water.
- **B** The official time for establishing records shall be achieved and determined in accordance with article 306.6.
- <u>C</u> Swimmers applying for a USMS postal record in an individual or relay event must submit a copy of their split sheets in addition to their event entries.
- 308.1.5 USMS records for individual postal swims may be established by using a

swimmer's split time in an individual event if: **D** An individual may use the split time in one event to establish a USMS record in a different event if:

- (1) A The split is swum as an initial distance within an event,
- (2) **B** The swimmer completes the full distance of the event,
- (3) C The intent to record a split time is brought to the attention, in writing, of the event director at the time of entry in the longer event, and
- (4) **D** A stopwatch or electronic timing system is used to record the record split in accordance with article 306.56.
- <u>E A relay team may use their split times in one event to establish a USMS record in a different event if:</u>
 - (1) Each split is swum as an initial distance within an event,
 - (2) Each swimmer completes the full distance of the event,
 - (3) The intent to record a split time for each swimmer is brought to the attention, in writing, of the event director at the time of entry in the longer event, and
 - (4) A stopwatch or electronic timing system is used to record the record split in accordance with article 306.6.

Rationale for A, B, and C: This proposal defines specific requirements for both cable and postal swims, all of which follow current practice.

- Stationary water is already required for cable swim course in article 302.3A, but is included here for information and emphasis using language that parallels article 105.3.4. Fresh water is not currently required for cable swim courses, but this issue is most because there are no current or likely future salt water cable courses.
- Fresh water is already required for postal swims in article 306.1, but is repeated here for information and emphasis using language that parallels article 105.3.5.

Rationale for D and E: Paragraph E provides for use of split times to establish relay records in different events with the same caveats that apply in individual events. The change in D is to provide parallel language with E.

Note: Amended 308.1.5A and 308.1.6A from August pre-convention version to improve grammar and parallel the wording of Part 1. Amended 308.1.6D to use "the" instead of "their."

A swim of less than 5 kilometers shall not begin if the water temperature exceeds 87.8° Fahrenheit. (31° Celsius) 31 degrees Celsius (87.8 degrees Fahrenheit).
