Topic: Long Distance Forum - September 7, 2021

The meeting was called to order at 8:01 pm ET:

- 1. Welcome and opening remarks Ali Hall.
- 2. Rules Discussion Jim Davidson and Alana Aubin.
 - LD-1:
 - Question What is the background/thinking behind merging open water and the long distance committee? Answer In 2010, the OWC was created at the demands of the LDC which at that time had too much on its plate and the work was overwhelming. LDC was to deal with rules and run the long distance championships. OWC was to develop and create open water opportunities. In recent years, the OWC has felt that, justifiably, much of its work was being done by the NO and so a year ago, a trial run to streamline the functions of both committees together was undertaken. This trial run was successful and so reintegration is recommended.
 - LD-2:
 - Question If we're defining things, why is this not in the glossary? Answer Because last year someone noted that this item is only mentioned in this context so it made more sense to define it in part 3.
 - Question Other parts of the rulebook do mention various forms of "host". Answer

 perhaps a more generalized version of "host" which could apply to all events
 including pool, long distance, open water, and epostal could be added to the
 glossary as a definition.

- LD-3:
 - Question Suggest an addition to 306 to add "long distance". Answer Will be taken into consideration.
- Other Discussion Items:
 - Question Member suggests an addition to epostal events to allow nonconforming events. Answer – Nothing in the rulebook prevents these, they just don't come under LDC jurisdiction.
 - Question A member has made an analysis of the differences between USMS, USA, and FINA open water rules which may be necessary for review and consideration of revision of our rules to attempt to get some continuity between the governing bodies. Answer This is a pet project of several committee members and would love to discuss further to get some further input on prioritizing changes.
