- 1. How can USMS support its members during the COVID-19 shutdown and assist its members, clubs, and workout groups once facilities are allowed to reopen? Reemerging from this shutdown is going to be unique for every program. Frequent and regular communication between and among the USMS Committees, the Board of Directors, the National Office, and LMSCs will be necessary to help get coaches and programs back in business. Connecting and sharing will be critical from local to national and everything in between. During this stay-at-home period, we have become very skilled at connecting remotely. This will be a critical skill as we begin to resume our activities and face new challenges of bringing clubs and workout groups back to life. Keeping the information flow moving and being willing and able to talk and listen to members/coaches/programs will be important and necessary lifelines.
- 2. How can USMS sustain and grow its membership? USMS needs to offer benefits and programming to enhance the experience of its existing membership to retain them. By continuing to gather and analyze membership data, USMS will be able to better understand and offer more specific/greater value to members. USMS also needs to continue to attract younger members through opportunities such as College Club Swimming, a program that has tremendous growth potential. Other pipelines need to be more thoroughly explored as potential membership opportunities like ALTS programming graduates. Providing online written workouts for these beginning swimmers might be one incentive for them to join USMS. Fitness members cannot be overlooked as they make up a large and important part of our membership. Including relevant content in Swimmer magazine and online workout options might be incentives for them to join or renew.

I think we've implemented several things to move in the right direction the last two years. There is still work to be done, and though there are a lot of unknowns as of this packet submission, I look forward to continue to support the organization as we get to where we want to go.

# What do you consider to be the major issues facing USMS now and in the future? As a person holding an elected position within USMS, how would you address these issues?

The Covid-19 pandemic has tested our resolve.

There are three major issues facing USMS, the downward trend in membership, providing more benefits for our members, and providing assistance to clubs and programs beyond monetary needs trying to relaunch after Covid 19.

The key to increasing membership is through our coaches and their education because they are the life blood of our organization. They develop programs, recruit new members and motivate swimmers to register and renew.

I think there is a direct correlation between the decline in membership and the US Masters Swimming educational offerings we offered over the past few years, which needs to change. While COVID-19 has changed the way, we will operate in the future, but there is still a need for face to face classes where coaches can network. Our Coaches Certification Program and Club Development Program was the only program in US Masters Swimming which actually reached out to the membership and came to their area.

Many programs have part-time coaches or part time leaders, there will be a need for help to re-launch these clubs and programs. While LMSC and USMS relief funds are helpful, to restart master's programs there needs to be resources available for someone who has the ability to talk to school superintendents, university athletic directors, or aquatic directors. If we start diverting resources towards educating our coaches and helping leaders at the local level, we can reverse the downward membership trend.

Amazon's business success and secret sauce is tied to their obsessive-compulsive focus on their customer, while their competitors ruminate over other competitors. USMS needs to have this same philosophy. We are invested heavily in technology. Good communication is important to our members; and provides valuable information to them. However, we need to provide more benefits for our members beyond the website.

The frontline Coaches and definitive leaders need education. If you think a greater investment of resources into technology is the path to take, then we will surely fail. If we start devoting resources towards educating our coaches and helping definitive leaders at the local level, there will be an increase in membership and will reverse the downward trend of membership.

As a past president and a USMS independent contractor I know who our member is, and what their needs are. I will work constructively with other Board of Directors to accomplish the best path for our organization.

These visits enabled MeI and I to get acquainted -- I was intrigued to learn that he was coached and mentored by Doc Councilman! -- and to discuss and debate Masters Swimming issues and initiatives. Over the past eight years I have come to know him as someone who embodies USMS's mission, who wears his emotions on his sleeve because he cares so deeply about our community, who has an unparalleled wealth of Masters Swimming experiences that inform his perspective and opinions, and who is always willing to help. But what has surprised me the most about MeI is that, despite his longevity, he is not tied to the past, but rather a proponent of strategic, data-driven, humanistic change.

Mel's background and accomplishments speak for themselves and, in my view, equip him with the knowledge and perspective to ask tough questions that should be asked and answered as the board maps out the future of USMS. In this respect, a <u>voting</u> board seat would give him that much more of a voice. With that in mind, and given the challenges we currently face, I encourage every delegate to closely consider Mel's nomination packet and unique qualifications.

#### Why are you interested in this position and why do you believe you would be a good candidate?

I am interested in this position because I like working with smart and highly capable people and those people tend to be board of directors junkies from the local to the national level! I have been considering running for an At-large Director position for about five years while waiting for the right time in my personal life. While I support Maddie Sibilia's candidacy for the Northwest At-large Director, I feel strongly that the Northwest Zone delegates need a choice when it is their time to discuss and endorse candidates for the position, so I am running as a floor nominee to provide that choice.

Two items pop out as the primary reasons I would be a good candidate for a director. First, is the leadership I demonstrated during the formative years of the LMSC Development Committee as chair to create its three-prong approach of supporting LMSCs through operational Standards, Mentoring LMSC leaders and Education opportunities at convention and beyond. That structure remains in place 9 years later. Second is my participation on the Governance Committee where I have been able to consider and contribute to questions about the framework of our organization and to benefit from the mentoring I've received from some of USMS's brightest minds.

# What do you consider to be the major issues facing USMS now and in the future? As a person holding an elected position within USMS, how would you address these issues?

The COVID-19 pandemic is the current issue for all of us. It has caused a lot of stresses: membership slump, reduced income for our organization and for many of our coaches, closed facilities, even more-restricted lane space. There are going to be opportunities as we pivot to a new normal: positioning swimming as a safer alternative to other indoor fitness activities.

But the major issue in USMS is the one that underlies our decreasing membership, our lack of volunteers in leadership positions and the waning enthusiasm to host swim meets: our continued reliance on the competition model. There is a reason why "meets" are called "meets;" it is an event designed to bring people together to see each other, share an experience and make a connection. For USMS's first 50 years, competition has been the driving force behind the need for our membership to "meet" and make those interpersonal connections. In our next 50 years we need to create a new "meet" to grow alongside our local and national championship competitions, one that brings our membership together in a cooperative, rather than competitive event. The ways in which I would help the organization along that path as a member of your board of directors include supporting a skilled and empowered national office willing to take risks to try new ideas, providing direction to staff and local leadership, and ensuring a feedback mechanism focused on customer/member experience and value.

#### Why are you interested in this position and why do you believe you would be a good candidate?

Two years ago, when I submitted this nomination packet for what would be my first term on our Board, I had absolutely no idea how much more passionate about our organization and members the experience would lead me to become. My love for swimming and desire to serve this community have not changed. Rather, they've only been strengthened. As many of you might know, I moved across the country from Atlanta to Seattle last year, away from all of my friends and family and into the great unknown. It has been a tough transition, so without a doubt, swimming outside at 5am has often become the brightest spot in

navigating the uncertainty of my career and life ahead of me, as have the people I've met across the country through USMS. And I hope to continue serving our organization in a way that provides lasting value for current and future members to take part in the sport we all love.

Why do I believe I am a strong candidate? There is one underlying thing I've learned about my approach and perspective through serving on the Board these past two years: I am not afraid to question the status quo, put forth new ideas, or ask "why" or "why not." During elections and as I started my term on the Board, I think at first I was intimidated by the breadth and tenure of experience surrounding me and was more hesitant to speak up, but I quickly learned to really take ownership of my "newness." It's helped me, and hopefully helped our organization, challenge beliefs and assumptions, consider new perspectives, and think outside the box. I've gained confidence in asking questions and sharing my own thoughts and ideas as a member of a demographic that previously has not had much of a hand in shaping our strategy from the top down, and I hope to continue to be an advocate for future generations of masters swimmers. Even two years into serving on the Board, I still believe I bring a valuable, fresh perspective that our organization needs in order to continue to grow, develop, and thrive in the years to come, and I'd love the opportunity to be an integral part of formulating our path in these next two years and beyond.

# What do you consider to be the major issues facing USMS now and in the future? As a person holding an elected position within USMS, how would you address these issues?

One area for growth I see lies in streamlining our local and national strategies surrounding membership and volunteers, both from the top down and bottom up. It's no secret that our local volunteers make up the heart of our organization as they interact directly with members on a daily basis. That said, there are opportunities for USMS to provide more support to our local level volunteers and members through education, programming, and events in order to ensure our members can have a consistent experience regardless of where they swim. Having now lived in two LMSCs and practiced with multiple different clubs/workout groups just in the past year, I feel I now have a better understanding of just how different the member experience can be based on the information and tools their clubs or coaches have and use. Whether it be in relation to communication from clubs or LMSCs to members, resources given to coaches to help them tailor workouts to meet their swimmers' needs, supporting officials in obtaining and maintaining certification, dissemination of information directly to members, or providing new benefits, the first step in ensuring our volunteers are more than prepared to carry out their roles will be educating them about the opportunities and resources they can take advantage of and the avenues to go about doing so.

The second important area of growth I see is in succession planning. We are lucky to have such an incredible group of volunteers and members that have supported our organization for many years. We will no doubt continue to need that volunteer support, but we must also find the best way to maintain and house that institutional knowledge for future generations of USMS volunteers. Simultaneously, we need to invest in getting new faces and new voices involved in the conversation to shape the future and determine the course of where we're headed. There are perspectives we haven't heard, ideas we haven't considered, and demographics we haven't included, and I think there is more we can do at all levels to encourage passionate members to get more involved.

The last, and perhaps biggest, area for improvement is in our internal resistance to change, and while I've personally seen amazing strides made in the last two years, there is still room to grow.
