From James Biles on the Forum, in order to transition liaison duties for this event: Merchandising preps should be completed this week. The draft online entry form is available but not yet updated. Major changes this year that need to be reflected on the entry include:

The deadline for registration/entry is one day after the swim time frame. In past years, it was up to 10 days after event time period to swim. It is now the day after this so we can get results out to members sooner. Since the event time frame is Jan 1st - Feb 28th, the entry deadline is March 1st.

Group entries by clubs will be permitted (30+ swimmer only). The event host needs to add verbiage that clubs desiring to do group entries must contact the host and work with CA to enter their swimmers. Also include a reminder that group swims should be swum so that all entries can be completed by the deadline of March 1st. There will be no exceptions to extend beyond this deadline.

Remember that waivers are no longer required for the postal events per rules passed by the HOD at convention (Rules 202.1.1 and 204.1 apply).
